**PROVISIONS:**

A. The individual signing this Application on behalf of Exhibitor represents and warrants that he/she has the authority to contractually bind Exhibitor applying for exhibit space. The individual signing this Application also represents and warrants that the product sought to be exhibited by Exhibitor qualifies for the Exhibition. If at any time INTERNATIONAL BUSINESS COUNCIL OF FLORIDA determines, in its sole and absolute discretion, that such product does not qualify for the Exhibition, INTERNATIONAL BUSINESS COUNCIL OF FLORIDA shall have the right to immediately terminate this Application and cancel the exhibit space.

B. INTERNATIONAL BUSINESS COUNCIL OF FLORIDA reserves the right to reassign exhibit space so as to ensure the safety and/or convenience of exhibition participants as well as to avoid conflict of product and/or exhibitors. Exhibits must be confined to and maintained within the space(s) leased.

C. INTERNATIONAL BUSINESS COUNCIL OF FLORIDA shall not be held liable for any loss, injury, or damages, costs or expenses sustained by Exhibitor or any of Exhibitor's personnel, including, but not limited to, Exhibitor's agents, servants, guests, or employees, except to the extent such loss, injury, or damages are solely caused by the gross negligence or willful misconduct of INTERNATIONAL BUSINESS COUNCIL OF FLORIDA or its agents or employees, and not otherwise.

D. INTERNATIONAL BUSINESS COUNCIL OF FLORIDA shall not be responsible for any lost business, loss of profits, injury, damage or expense, of whatever nature that Exhibitor may suffer due to a cancellation of the Exhibition as a result of conditions that render the event impracticable as determined by INTERNATIONAL BUSINESS COUNCIL OF FLORIDA in its sole and absolute discretion. Causes of impracticability include, without limitation, casualty, explosion, fire, lightning, utility interruption, flood, weather, epidemic, hurricane, tornado, earthquake or other acts of God, or any law, ordinance, rule or regulation, acts of public enemies, strikes, riots, or civil disturbances.

E. Exhibitor hereby agrees to defend, indemnify, and hold harmless INTERNATIONAL BUSINESS COUNCIL OF FLORIDA and its affiliates and their respective members, officers, managers, shareholders, directors, contractors, agents employees, successors, and assigns (the "Indemnities") with respect to any claims, suits, damages, liabilities, losses, expenses, and costs (including reasonable attorneys' fees) which the Indemnities may suffer or be subject to arising from or in relation to this Application or the presence of Exhibitor or Exhibitor's personnel at the Exhibition; provided, however, that Exhibitor's duty to indemnify and hold harmless the Indemnities shall not extend to such claims, suits, damages, liabilities, losses, expenses, and costs (including reasonable attorneys' fees) as are solely caused by the negligence or willful misconduct of the Indemnities.

F. This Agreement shall be governed by, and construed and enforced in accordance with the laws of the State of Florida, without regard to its conflicts of law provisions. All legal proceedings arising under this Agreement shall be conducted in the courts situated in Miami-Dade County, Florida, which courts shall have exclusive venue and jurisdiction. This Agreement may only be altered or amended by an instrument in writing properly executed by both parties. This Agreement, including any exhibits attached hereto, embodies the entire agreement of the parties hereto in respect of the subject matter hereof and no representation, inducements, or agreements, oral or otherwise, between the parties not contained and embodied herein shall be of any force and effect. This agreement may be executed in any number of counterparts, each of which shall be an original but all of which taken together shall constitute one and the same instrument.
